PROCLAMATION – LAUNCHING THE MONTGOMERY TOWNSHIP MAYOR'S WELLNESS CAMPAIGN – Mayor Singh read the proclamation into the record.

WHEREAS, across New Jersey, the conditions in which we live, work and age in combination with wellness, particularly rising obesity rates and decreasing physical activity, impacts our overall health; and

WHEREAS, the New Jersey Health Care Quality Institute's Mayors Wellness Campaign, in partnership with the New Jersey League of Municipalities, recognizes that Mayors and other local leaders can be effective champions of community health and wellness; and

WHEREAS, the goal of the Mayors Wellness Campaign is to improve the health and wellness of New Jersey communities; and

WHEREAS, the Mayors Wellness Campaign provides communities with technical assistance, evidence-based resources, and other support to implement community health and wellness improvement initiatives; and

WHEREAS, the Township of Montgomery cares deeply about all of its residents and the future health and wellness of its community members; and

WHEREAS, the Mayors Wellness Campaign will work to implement a comprehensive program to create and sustain local activities to improve wellness in Montgomery Township.

NOW, THEREFORE, BE IT RESOLVED that I, Mayor, Neena Singh, on behalf of the Township Committee, ask that all residents of this community join me in supporting and actively engaging in our local Mayors Wellness Campaign.

BE IT FURTHER RESOLVED that I, Mayor, Neena Singh, on behalf of the Township Committee, encourage the residents of Montgomery Township to participate in the Mayors Wellness Campaign activities as we work towards living healthier lives and improving the health and wellness of our community.

PROCLAMATION - RECOGNIZING THE MONTH OF JANUARY AS RADON ACTION MONTH - Mayor Singh read the proclamation into the record.

WHEREAS, prolonged exposure to radon can kill as many as 500 people in New Jersey each year; and

WHEREAS, families who reside in homes with elevated radon levels are at risk of developing serious health problems; and

WHEREAS, any home could have high levels, even when neighboring homes do not; and

WHEREAS, radon testing can be done with great ease at a relatively low expense to the homeowner, with the cost of reducing radon concentrations being comparable to a home repair; and

WHEREAS, the New Jersey Department of Environmental Protection and the United States Environmental Protection Agency are collaborating during the month of January to promote the need for radon testing in an effort to protect the lives of our state's residents.

NOW, THEREFORE, I, Neena Singh, Mayor of the Township of Montgomery, on behalf of the Township Committee, hereby proclaim the month of January 2024 as Radon Action Month in the Township and call upon all residents who have not yet tested to test their homes for radon and to reduce levels if elevated levels are found, to protect their families from the serious health risk of radon.

AUTHORIZING LEASE OF PUBLIC PROPERTY BY SUBMISSION OF SEALED BIDS FOR WIRELESS TELECOMMUNICATIONS FACILITY

WHEREAS, pursuant to the provisions of the Local Lands and Buildings Law (N.J.S.A. 40A:12-14) ("LLBL") a municipal corporation may lease to any private person real property owned by said municipal corporation which is not needed for a public use; and

WHEREAS, the LLBL requires that a lease by a municipal corporation to a private person, except for a lease to a private person for a public purpose, be made to the highest bidder by open public bidding at auction or by submission of sealed bids; and

WHEREAS, the Township of Montgomery ("Township") currently leases a 45-acre parcel of property identified on the Township Tax Map as Block 20001, Lot 10.05 (the "Property") pursuant to a Lease Purchase Agreement with the Somerset County Improvement Authority; and

WHEREAS, the Lease Purchase Agreement allows the Township to rent or lease the Property; and

WHEREAS, there are substantial gaps in wireless communications service and emergency services communications coverage in Skillman; and

WHEREAS, there is a need to provide for wireless communications service and emergency services communications coverage in Skillman; and

WHEREAS, the Township has determined to lease an approximately 3,000 square foot area of Block 20001, Lot 10.05, north of Orchard Road and west of Community Drive (the "Premises"), which Premises is not needed for public use and which is suitable for the construction of a wireless communications tower which will address the need for wireless communications service and emergency services communications coverage in Skillman.

WHEREAS, the improvements and the related support facilities shall be constructed at the sole cost and expense of the successful bidder and the Township shall have the right to locate its antennas to said tower once constructed.

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Montgomery, County of Somerset, State of New Jersey as follows:

- 1. Pursuant to N.J.S.A. 40A:12-14, the Township, through its Administrator or designee, is hereby authorized and directed to solicit sealed bids for the lease of the approximately 3,000 square foot area of Block 20001, Lot 10.05, north of Orchard Road and west of Community Drive (the "Premises") for purposes of designing, constructing and operating a wireless communications tower and ancillary support equipment, structures and foundations on the Premises; at such time and place as deemed appropriate and necessary to effectuate the terms hereof.

Said advertisement shall specify that the minimum rental bid shall be \$40,000 and that the Township reserves the right to reject all bids where the highest bid is not accepted.

SUPPORTING THE DESIGNATION OF THE SOURLAND MOUNTAIN REGION AS A SPECIAL RESOURCE AREA

WHEREAS, the Township of Montgomery previously supported the designation of the Sourland Mountain Region ("Region") as a Special Resource Area ("SRA") in the State Development and Redevelopment Plan by Resolution #04-8-286, adopted August 19, 2004 which recognized that the Sourland Mountain Region comprises the headwaters of many streams in the Region and surrounding towns; that its forested areas maintain the stream water and groundwater quality, including drinking water; that it provides habitat for many threatened and endangered species as well as offers many unique scenic, historic, agricultural and recreational resources for residents and visitors; and

WHEREAS, the Township of Montgomery remains desirous in supporting the designation of the Sourland Mountain Region as a Special Resource Areas; and

WHEREAS, the Sourland Mountain Region, defined by its unique geology, encompasses 90 square miles, including parts of eight municipalities in Mercer, Somerset and Hunterdon Counties; and

WHEREAS, the Sourlands, home of the largest contiguous forest in Central New Jersey, are an island of biodiversity in a sea of encroaching sprawl; and

WHEREAS, the Sourlands are home to dozens of rare and endangered species of plants and animals, and an irreplaceable stopover for migrating birds; and

WHEREAS, the Sourland forest is the most intensive carbon sink anywhere in New Jersey; and

WHEREAS, more than 90 miles of streams in the region are "first order" streams, the critical headwaters to the Raritan and Millstone Rivers, an important source of drinking water for New Jersey residents; and

WHEREAS, the Sourlands are enjoyed and relied on by countless urban and suburban New Jerseyans as a recreational resource; and

WHEREAS the Sourland forest is losing more than a million trees (about a quarter of the forest) to the Emerald Ash Borer, and more to emerging threats; and

WHEREAS, natural forest regeneration is impossible in the Sourlands because of the vast overpopulation of white-tailed deer; and

WHEREAS, the State of New Jersey is currently updating the State Plan; and

WHEREAS, designation of the Sourlands as a Special Resource Area in the State Plan would have numerous benefits, including:

- State recognition of the importance of the Sourlands will help with both the public and private preservation of land.
- The SRA designation will help attract both public and private funding for reforestation efforts.
- The SRA designation will lay the groundwork for any needed legislation to protect the Sourlands.
- The SRA designation will help with efforts to bring the deer population under control.
- The SRA designation will call attention to the need to protect the quantity and quality of surface waters and groundwater of the region.

NOW, THEREFORE, BE IT RESOLVED that the Township of Montgomery, County of Somerset, New Jersey supports the designation of the Sourland Mountain Region as a Special Resource Area and urges the State Planning Commission to include this designation in its current update of the State Plan.

CORRESPONDENCE

APPROVAL OF MINUTES

Resident email regarding lighting at Mill Pond Park and taxes – Township Clerk, Lisa Fania, explained that a resident had inquired about the possibility of installing lighting at Mill Pond Park and that the inquiry is for consideration and discussion by Committee Members at a future meeting.

At this time, Mayor Singh invited the resident in attendance to the podium for comment.

Chase, a resident from Belle Mead, appeared before the Committee requesting that the Township consider the installation of lighting at Mill Pond Park. Chase explained that resident youths utilize the park for soccer practice and have to travel to other areas due to daylight restraints. Committee Member Ahn commented that the Township will contact surrounding property owners and look into the request.

NEW BUSINESS

There were no matters of new business for discussion.

TOWNSHIP COMMITTEE REPORTS

Committee Member Ahn reported on behalf of the Economic Development Commission advising that the Farmers' Market is being relocated to the Municipal Complex and that the Winter Market will be held in the library meeting room February 24, March 30, and April 27. Committee Member Ahn announced the next meeting date, February 5.

Committee Member Ahn reported on a meeting of the Board of Health advising that discussion was held regarding Radon Action Month and the importance of radon testing, as well as the launching of the Mayor's Wellness Campaign with a collaboration of efforts from various departments and organizations to keep Montgomery active and healthy. Committee Member Ahn announced the next meeting date, February 14.

On behalf of the Agricultural Advisory Committee, Committee Member Ahn voiced praise and extended congratulations to property owners of Hidden Spring Lavender & Alpaca Farm which was featured on the cover of NJ Monthly Magazine. Committee Member Ahn also acknowledged and extended gratitude to Montgomery Township resident Brad Fay for getting central NJ on the map.

Committee Member Taylor Todd advised that she will once again be serving on the Inclusion & Equity Committee and the Landmarks Commission for 2024, as well as the Municipal Alliance/Youth Services Commission. Committee Member Taylor Todd reported that the Landmarks Commission held an event in December celebrating two distinguished members of the Commission for their dedication and invaluable service to the community, Liz Palius and Jessie Havens. Committee Member Taylor Todd also announced that Liz Palius will be retiring.

Committee Member Taylor Todd reported on the reorganization meeting of the Inclusion & Equity Committee announcing that Catherine Lugg will be the Chair and Nancy Harrington, Vice Chair. Committee Member Taylor Todd extended gratitude to both members for their invaluable commitment to service as well.

Committee Member Keenan advised that lobbying efforts for an additional Public, Educational and Governmental (PEG) channel for Central NJ Network from Comcast are underway. Committee Member Keenan also advised that the Environmental Commission meeting was cancelled due to weather.

Deputy Mayor Barragan reported that the meeting of the Veterans Memorial Committee was cancelled due to weather and rescheduled for January 30. Deputy Mayor Barragan announced that there will be a presentation on the Vietnam War, sponsored by the Harlingen Historical Society, Saturday, January 20, 2:00 p.m. in the library.

Deputy Mayor Barragan also reported on a meeting of the Open Space Committee advising that discussion was held regarding preservation and maintenance of open space properties. Deputy Mayor Barragan continued that significant discussions have been taking place with both the Open Space and Shade Tree Committees regarding the tree ordinance. Deputy Mayor Barragan commented that the Shade Tree Committee is seeking volunteers to assist at Village Elementary with upcoming Arbor Day.

Deputy Mayor Barragan reported that discussions regarding the 2024 Municipal Budget have begun with the Budget and Finance Committee. Deputy Mayor Barragan explained that meetings will begin shortly with department heads; and that there will be opportunity for public comment and periodic updates of the process will be provided as adoption will take place in May.

Mayor Singh also advised on efforts of the Budget and Finance Committee; reported on the launching of the Mayor's Wellness Campaign and initiatives including the upcoming Rabies Clinic, Farmers' Market and "Beat the Winter Blues" event with much more to come. Mayor Singh also provided a brief explanation of the roles and responsibilities of the Planning Board.

ADMINISTRATOR'S REPORT

Administrator Savron reported on the outstanding efforts of Township Departments including Office of Emergency Management, Police, Public Works, Parks and Recreation, Sewer, Health and the Fire Companies and EMS during the most recent severe weather events. Administrator Savor provided a brief explanation of the "behind the scenes" planning and coordination among the departments and external agencies such as the County.

Mayor Singh spoke briefly about a recent meeting of the Local Emergency Planning Council which is now headed by the County and offered words of praise for its effort in emergency planning. Committee Member Keenan also acknowledged and commended the Township's improved emergency planning.

Regarding Municipal Center updates, Administrator Savron explained that Committee Member Taylor Todd advised of a safety issue regarding the height of the threshold at the front door and that the repair is in process; and that lighting and landscaping have been installed at the Route 206 sign.

During the Administrator's Report, an inquiry was made regarding the status of the Promenade development project. Attorney Rubinstein Quiroga advised that the plat has been filed with the County and that the next step involves compliance review with internal departments which is underway. Attorney Rubinstein Quiroga also explained that a plat is a large map that is filed with the County for developments similar to that of a survey for residential properties.

FUTURE AGENDA ITEMS

Inclusive Playground — Administrator Savron explained that the Township is pursuing an NJDEP grant opportunity in the amount of \$500,000-plus for funding of an all-inclusive playground, and that there will be a public hearing at the next Township Committee meeting offering the public the opportunity to learn more about the project and ask questions. Administrator Savron continued that there will also be a resolution on the next meeting agenda authorizing the submission of the grant application to the State. Administrator Savron also gave a brief description of Jake's Law, a law that incentivizes counties and now municipalities to build playgrounds for children and adults of all backgrounds, ages and physical abilities to play together without limitations.
