7. **RESOLUTION HONORING SHELLY BELL**

WHEREAS, a community derives its strength from people who endeavor to help others and contribute to the public good; and

WHEREAS, Shelly L. Bell has worked diligently on behalf of Montgomery Township residents during her years of service to the Montgomery service; and

WHEREAS, Committeeperson Bell left public office in October of 2022, having served Montgomery Township in the following capacities:

WHEREAS, during her years of service, Shelly faithfully performed the duties and obligations of the office, and has given her utmost to the residents of Montgomery; and

WHEREAS, much of Shelly's focus has been on establishing and strengthening community relationships by establishing events such as Coffee with a Cop, celebrating Juneteenth, and for rallying support for Ukraine, and for the Asian community after the 2021 Atlanta Spa terrorist shootings; She also led the search and transition for our new Township Administrator; and

WHEREAS, Shelly L. Bell has set a standard for excellence in public service with her civility, humility, determination, dedication and sense of humor.

NOW, THEREFORE, BE IT RESOLVED that we, the members of the Montgomery Township Committee on behalf of the people of Montgomery, express our deepest appreciation to the Honorable Shelly L. Bell for outstanding service to our community, and extend a fond farewell and warmest wishes for the future to Shelly on this 10th day of November 2022.

8. **PUBLIC COMMENT**

We respectfully ask members of the public to limit your comments to approximately five (5) spoken minutes. Additionally, if your comments are similar to comments already made, instead of repeating them at length, we ask that you instead indicate that you join in or support those comments previously made.

- 8-1. Anika Risso, 381 Mountain View Road, voiced concerns in regards to proposed changes to the former Golden Beck Farm, now known as the Green Flash Farm. She stated that she wanted to make the township aware of the potential impact of traffic as well as the environmental health and overall safety concerns if the two new buildings proposed are to be completed.
- 8-2. Jeffrey Grant, 6 Livingston Drive, congratulated Police Captain Silvio Bet. He then asked Mayor Keenan to answer his questions from a previous meeting with regard her domestic threat comments. Mayor Keenan acknowledged Mr. Grant's repeated statements and reminded him that public comment should be focused on what is happening on the agenda or within the township.
- 8-3. Jeffrey Sydnor, 381 Mountain View Road, wanted to voice his support of Mrs. Risso's previous concerns. He noted that the farm could be a part of the Blawenburg historical district.
- 8-4. Shelly Bell, 14 Hartwick Drive, thanked the Committee for the opportunity to serve with them and congratulated Mayor Keenan and Committeeperson Barragan on their successful election.
- 8-5. Marilyn Blazovsky, 14 Andover Circle, congratulated Police Captain Bet, Mayor Keenan, Deputy Mayor Singh and Committeeperson Barragan and welcomed new Committeeperson Todd.
- 8-6. Bill Forbes, Griggstown Road, stated that in May of 2019, the Van Harlingen Historical Society hosted an event at the Green Flash Farm. It was a continuation of the May in Montgomery event with total attendance being 95 people. Events did and can happen at this location without becoming a safety or traffic concern.
- 8-7. Allen Wirsul, 24 Ridgeview Drive, voiced his concern that challengers held lists of people at the polling locations. He was also concerned that challengers could have been candidates. Mayor Keenan acknowledged Mr. Wirsul's concerns and suggested he reach out to the Board of Elections.
- 8-8. Susan Rogers, 80 Ichabod Crane Lane, asked additional questions regarding the "PILOT" project mentioned in previous meetings. Mayor Keenan suggested to Ms. Rogers set up a meeting with Township Administrator Lori Savron to get her questions answered. Ms. Rogers stated she dislikes private conversations and wants to keep everything as a public discussion. She followed up with a question in regards to the Affordable Housing Trust Fund and if the funds for this project are coming from those funds and the impact on the taxpayers. Mayor Keenan stated there would be a presentation dedicated to this project in January and all the questions that she had will be answered. She suggested Ms. Rogers send her questions to Staff prior to the meeting, so everyone can be prepared to give complete answers.
- 8-9. Administrator Savron responded to the concerns for Mountain View Road and the farm. She discussed the Right to Farm Act and that the Green Flash Farm holds protection under that Act. She noted the Township is aware that the application will be heard on Monday November 28 at 8 am.

B. **RESOLUTION #22-11-232 - AUTHORIZING USE OF COMPETITIVE CONTRACTING FOR THE PROCUREMENT OF AN AUTOMATED TELLER MACHINE (ATM)**

WHEREAS, N.J.S.A. 40A:11-4.1(b)(j) permits competitive contracting to be utilized to procure concession services for an Automated Teller Machine (ATM) that warrant a qualitative evaluation of specialized goods or service providers to determine the provider that is most advantageous, price and other factors considered; and

WHEREAS, N.J.S.A. 40A:11-4.3(a) requires that in order to use competitive contracting for the first time for a specified purpose, the governing body shall pass a resolution authorizing the use of competitive contracting for such purpose; and

WHEREAS, N.J.S.A. 40A:11-4.3(b) requires that the competitive contracting process shall be administered by a designated Authorized Agent who may be a purchasing agent pursuant to N.J.S.A. 40A:11-9, or by legal counsel of the contracting unit, or by the chief administrative officer of the contracting unit; and

WHEREAS, the Township Committee has determined that the procurement of an ATM through the use of competitive contracting is in the best interest of the Township.

NOW, THEREFORE, BE IT RESOLVED, by the Township Committee of Montgomery Township, County of Somerset, State of New Jersey, that:

1. The aforesaid recitals are incorporated herein as if set forth at length; and
2. The Township Purchasing Agent is authorized to initiate competitive contracting for the solicitation of proposals for an ATM and to publicly advertise and solicit bids for the ATM pursuant to and in accordance with the provisions of the Local Public Contracts Law.

C. **RESOLUTION #22-11-233 - AUTHORIZING THE TOWNSHIP OF MONTGOMERY TO ACCEPT SUBGRANT AWARD OF THE FEDERAL FISCAL YEAR 2022 OF EMERGENCY MANAGEMENT PERFORMANCE GRANT AND EMERGENCY MANAGEMENT AGENCY ASSISTANCE**

WHEREAS, the Montgomery Township Office of Emergency Management has been awarded State Homeland Security Grant Program Sub-grant AFN #97.042, Subgrant Award #FY22-EMPG-EMAA-1813 from the New Jersey Department of Law and Public Safety, Office of the Attorney General. The subgrant, consisting of \$10,000.00 Federal Award is for the purpose of enhancing the Township's ability to prevent, protect against, respond to and recover from acts of terrorism, natural disasters and other catastrophic events and emergencies; and

WHEREAS, the Township of Montgomery will use these funds to enhance your Emergency Management Program and that the funds will be used for Emergency Management purposes; and

WHEREAS, the award period is from July 1, 2022 to June 30, 2023; and

WHEREAS, the subgrant award incorporates all conditions and representations contained or made in application and notice of award; and

WHEREAS, Montgomery Township Office of Emergency Management, designated by the New Jersey State Police, Office of Emergency Management, has submitted an Application for Subgrant Award that has been required by the said New Jersey State Office of Emergency Management.

NOW, THEREFORE, BE IT RESOLVED by the Montgomery Township Committee, in the County of Somerset, State of New Jersey:

1. That the Committee accepts the award of the FFY22 Emergency Management Performance Grant Program (EMPG), Emergency Management Agency Assistance Subgrant (EMAA) in the amount of up to \$10,000.00 Federal Funds from the New Jersey State Police, Office of Emergency Management.
2. That the Chief Financial Officer and Director of Emergency Management are authorized to sign the appropriate subgrant award documents.
3. That copies of this resolution shall be forwarded to the New Jersey State Police, Office of Emergency Management, the Montgomery Township Administrator, the Chief Financial Officer and the County Division of Emergency Management and Office of Treasury.

D. **RESOLUTION #22-11-234 - SUPPORTING THE SUBMISSION OF MONTGOMERY TOWNSHIP'S FARMLAND PRESERVATION PROGRAM MUNICIPAL PLANNING INCENTIVE GRANT PROGRAM FY2024 PLANNING ROUND APPLICATION**

WHEREAS, the Agriculture Retention and Development Act establishes the State Agriculture Development Committee (SADC) to implement the preservation of farmland through the retirement of development rights and the acquisition of agricultural easements; and

WHEREAS, over 1,300 acres of agricultural land have been preserved in Montgomery Township through the SADC Farmland Preservation Program; and

WHEREAS, the SADC enacted the Planning Incentive Grant (PIG) program in 1999 to enhance farmland preservation by providing grants to eligible counties and municipalities for easement acquisition; and

WHEREAS, N.J.S.A. 2:76-17A.6 requires municipalities to submit annual Farmland Preservation Program Municipal Planning Incentive Grant applications for each year's funding round to be eligible to receive funding for that round; and

WHEREAS, the Agricultural Advisory Committee reviewed and supported submission of the application at their October 10, 2022 meeting; and

WHEREAS, N.J.S.A. 2:76-17A.6(a)2iii(3) requires Municipal PIG applications be accompanied by a resolution of support by the Governing Body.

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Montgomery, Somerset County New Jersey that it endorses and supports the submission of the Municipal Planning Incentive Grant FY2024 Planning Round Application to the SADC.

BE IT RESOLVED that the Mayor and Clerk are hereby authorized to execute a First Amendment to a construction sequence agreement with Village Shoppes at Montgomery, LLC with respect to the Village Walk at Montgomery Development, Block 28007, Lots 1, 2, 3, and 4, Block 28005, Lot 60.01 (formerly Block 28005, Lots 60, 65, part of 66, 68 and 69), subject to review and approval by the Township Engineer and Township Attorney as to form and content.

F. **RESOLUTION #22-11-236 - AUTHORIZING RELEASE OF SAFETY AND STABILIZATION GUARANTEE FOR HACKENSACK MERIDIAN HEALTH CARE CARRIER CLINIC SECURITY FENCE - BLOCK 2002, LOT 2**

WHEREAS, the Township of Montgomery seeks to retain the services of professional engineering firm to provide construction administrative services during the construction of the Pike Brook Sewer Lateral Rehabilitation Project; and
