Montgomery Township

A Recent Record of Success

- Montgomery experienced a <u>decrease</u> in its municipal tax levy over the past 2 years (2009 & 2010)
 - Only 4% of NJ municipalities accomplished this feat (23 out of 566)
 - Montgomery's tax levy change was -0.3% as compared to the state average of +13.5%
 - Montgomery is one of only three Somerset County municipalities to achieve a decline in its tax levy
- Looking only at last year (2010):
 - Non-grant spending was reduced to 2004 levels
 - Montgomery's tax levy change was -0.4% as compared to the state average of +7.3%

2011 Budget Summary


- Beginning of the year budget gap = \$761,600
 - Mandatory Cost Increases:
 - Pensions PERS and PFRS \$138,700
 - Health Care \$257,900
 - Statutory and Contractual Salary Increases \$128,000
 - Decline in revenue of \$237,000
- Non-grant spending has been <u>reduced by \$132K</u>
 - Saved \$125K in health care costs by joining a self-insured fund with other local municipalities
 - Cut our electricity and natural gas bills by \$90-100K by seeking out new suppliers
 - Entered into shared services agreements with Hopewell and Pennington Boroughs to provide them health and animal control services

2011 Budget Summary


- Based on the new property tax cap (2% + exemptions), Montgomery is eligible for a 3.4% increase in municipal taxes
 - However, the proposed tax increase is <u>less than 1%</u>
 - \$24.89 increase per average household (to \$1,537.41)
 - Municipal tax rate up \$0.005 (to \$0.305)
- State Aid flat compared to 2010
- No reductions in services


2011 Preliminary Budget Revenues




2011 Preliminary Budget Expenditures



Total Budget Appropriations




Budgeted - Total Salaries and Overtime







- Our pursuit of "Doing More with Less" does not end with this budget – we are actively working on the following items:
 - Shared services agreement with Hillsborough for our municipal courts (potential savings of \$90K+)
 - Finalization of the Skillman Village deal with Somerset County (potential savings of \$120K+ in debt servicing)
 - Review of organizational structure, headcount, and responsibilities
- These items and others will not be in place for the 2011 budget, but are critical for keeping Montgomery's Record of Success going in 2012
