A RESOLUTION TO AFFIRM THE TOWNSHIP OF MONTGOMERY'S CIVIL RIGHTS POLICY WITH RESPECT TO ALL OFFICIALS, APPOINTEES, EMPLOYEES, PROSPECTIVE EMPLOYEES, VOLUNTEERS, INDEPENDENT CONTRACTORS, AND MEMBERS OF THE PUBLIC THAT COME INTO CONTACT WITH MUNICIPAL EMPLOYEES, OFFICIALS AND VOLUNTEERS

WHEREAS, it is the policy of the Township of Montgomery to treat the public, employees, prospective employees, appointees, volunteers and contractors in a manner consistent with all applicable civil rights laws and regulations including, but not limited to the Federal Civil Rights Act of 1964 as subsequently amended, the New Jersey Law against Discrimination, the Americans with Disabilities Act and the Conscientious Employee Protection Act; and

WHEREAS, the Township Committee of the Township of Montgomery has determined that certain procedures need to be established to accomplish this policy.

**NOW, THEREFORE, BE IT RESOLVED** by the Township Committee of the Township of Montgomery, County of Somerset, New Jersey that:

**Section 1:** No official, employee, appointee or volunteer of the Township of Montgomery by whatever title known, or any entity that is in any way a part of the Township of Montgomery shall engage, either directly or indirectly in any act including the failure to act that constitutes discrimination, harassment or a violation of any person's constitutional rights while such official, employee, appointee volunteer, or entity is engaged in or acting on behalf of the Township's business or using the facilities or property of the Township.

**Section 2:** The prohibitions and requirements of this resolution shall extend to any person or entity, including but not limited to any volunteer organization or inter-local organization, whether structured as a governmental entity or a private entity, that receives authorization or support in any way from the Township to provide services that otherwise could be performed by the Township.

**Section 3:** Discrimination, harassment and civil rights shall be defined for purposes of this resolution using the latest definitions contained in the applicable Federal and State laws concerning discrimination, harassment and civil rights.

**Section 4:** The Township Administrator shall establish written procedures for any person to report alleged discrimination, harassment and violations of civil rights prohibited by this resolution. Such procedures shall include alternate ways to report a complaint so that the person making the complaint need not communicate with the alleged violator in the event the alleged violator would be the normal contact for such complaints.

**Section 5:** No person shall retaliate against any person who reports any alleged discrimination, harassment or violation of civil rights, provided however, that any person who reports alleged violations in bad faith shall be subject to appropriate discipline.

**Section 6:** The Township Administrator shall establish written procedures that require all officials, employees, appointees and volunteers of the Township as well as all other entities subject to this resolution to periodically complete training concerning their duties, responsibilities and rights pursuant to this resolution.

**Section 7:** The Township Administrator shall establish a system to monitor compliance and shall report at least annually to the governing body the results of the monitoring.

**Section 8:** At least annually, the Township Administrator shall cause a summary of this resolution and the procedures established pursuant to this resolution to be communicated within the Township of Montgomery. This communication shall include a statement from the governing body expressing its unequivocal commitment to enforce this resolution. This summary shall also be posted on the Township's website.

**Section 9:** This resolution shall take effect immediately.

Section 10: A copy of this resolution shall be published in the official newspaper of the Township of Montgomery in order for the public to be made aware of this policy and the Township's commitment to the implementation and enforcement of this policy.

# **NEW BUSINESS**

Additional public cable channel – Mayor Keenan explained that Central New Jersey Network (CNJN) has located to 23 Orchard Road in the Township and that the Township would like to add CNJN as an additional channel in its current 15-year contract with Comcast. Mayor Keenan continued that the current contract allows for only two public, educational, governmental (PEG) access channels and that a formal request for additional channels must be submitted to Comcast. Attorney Rubinstein Quiroga commented that a resolution authorizing request will be considered at a future meeting.

Montgomery Farmers Market – Mayor Keenan advised of a request to have the Farmers Market relocated to the Municipal Complex from Village Shoppes and that discussion has been underway with the Department of Public Works and the Library. Mayor Keenan continued that the purpose of tonight's discussion is to determine if there are any objections by Committee Members regarding this request. Committee Member Ahn provided brief background regarding the Market and spoke of limitations at the current location including parking and restroom facilities. Committee Member Ahn also explained that there are three winter markets which will be held the last Saturday of February, March and April in the Library meeting room; and that the outdoor market will commence June 1. During the discussion, concerns were raised regarding liability to the Township and electrical requirements. There were no objections to the request for the relocation of the Farmers Market to the Municipal Complex. Authorization to be formally memorialized at a future meeting.

## **TOWNSHIP COMMITTEE REPORTS**

Committee Member Barragan advised of the unveiling of the Montgomery "Killed in Action Plaque," in memory of those residents killed in action, this evening, located near the library entrance. Committee Member Barragan also announced the date for the upcoming Veterans Day ceremony, Saturday, November 11, 2023 at Montgomery Veterans Memorial Park, 10:15 a.m. Committee Member Barragan advised that in the event of inclement weather the ceremony will be moved to the High School.

Mayor Keenan reported on a meeting of the Agriculture Advisory Committee advising that review of the Township's Farmland Preservation Plan is underway; and on a meeting of the Environmental Commission advising that the Township's tree ordinance is under review due to the State's new stormwater regulations. Mayor Keenan also reported on participation in the Mayor's Housing Workgroup explaining that the virtual roundtable discussions focus on preferences and expectations in preparation for the next round of affordable housing requirements. Mayor Keenan advised that she attended free NARCAN training sponsored by Robert Wood Johnson Hospital and encouraged Township Committee members, staff and residents to participate. Lastly, Mayor Keenan reported that the Township's "Trunk or Treat" event was very successful.

At this time, Committee Member Ahn also commented that the "Trunk or Treat" event was well attended with over 1,000 children and expressed gratitude to the Parks and Recreation Department for their efforts, as well as those who attended in making the event a success. Committee Member Ahn also reported that the Diwali Festival recently held at the High School (November 3, 2023) was very well attended and expressed gratitude to Deputy Mayor Singh for all of her efforts in coordinating the festival.

## ADMINISTRATOR'S REPORT

Administrator Savron provided an explanation regarding the Township's annual requirement to complete a Best Practices Inventory. Administrator Savron explained that the Best Practices Inventory is an annual survey that assesses a municipality's compliance with statutory and regulatory obligations. Administrator Savron continued that the Township did not receive points for compliance with a new state mandate regarding the Elections Pay-to-Play regulations or the mandate for a hybrid or electric vehicle purchasing policy. Administrator Savron explained that Ordinance #23-1712, introduced this evening, addresses the Pay-to-Play requirements and efforts are underway regarding the implementation of a policy for hybrid and electric vehicles.
